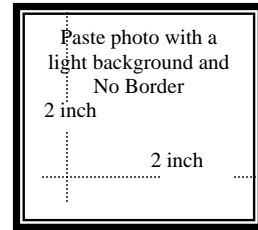

All applicants are required to apply in the prescribed Application form along with-

1. Two recent passport size photographs, 2. Prescribed Fee, 3. Passport in original (must be valid for a minimum period of six months).

Tourist Visa: Applicants are required to submit application form indicating the place(s) of visit, duration of stay and flight details/itinerary. For minor children (under 15 years) application **MUST** be furnished with following documents:

1. Copy of **Date of Birth** certificate,
2. **No Objection Letter** from both the parents along with the photocopy of the relevant pages of their passports to verify signatures,
3. Both parents **MUST** sign the visa application for minor children.
