 Applicants holding passport **not belonging** to the countries listed in **Table A, please refer to Table B & C** for applicable visa fees.

**Please add up fees** as applicable from Table A & C or Table B & C, based on your nationality. A VFS Service fee of A\$18.00 (including GST) is mandatory for each applicant irrespective of the mode of application submission. Also a postal processing fee of A\$8.00 (including GST) is mandatory for all applications sent by POST and covers return delivery. (1 or 2 applicants = A\$8, 3 to 4 applicants = A\$16)
